

# FY 2010: A Year to be Remembered

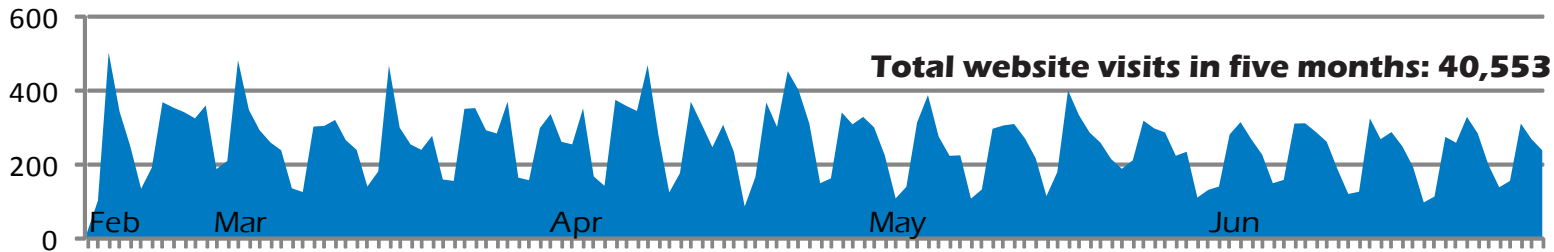

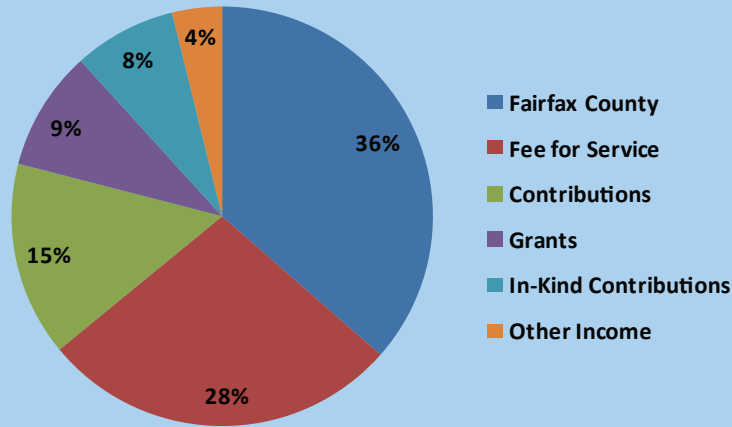

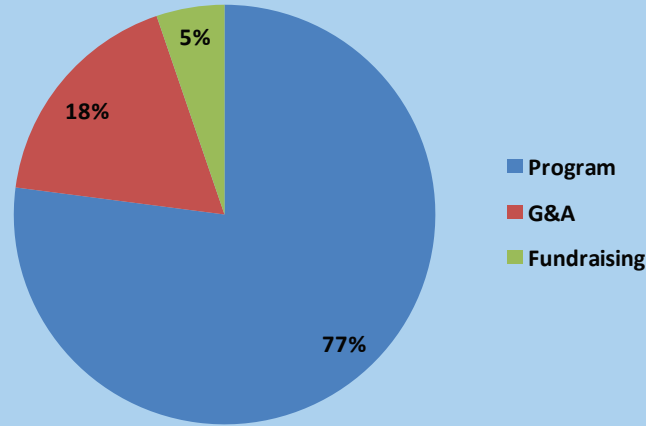
